All entries for the qualifying events must be made online through Golf Genius, via the NCGU website. The system will ask entrants for their CDH number and will request payment.

**The number of entrants at each event may be limited at the discretion of the NCGU, so entries will be accepted in the order they are received, with a waiting list maintained for any additional entrants.**

The decision of the NCGU Board in all matters relating to this Competition shall be final.

Players shall be advised of their starting tee-time no later than seven days in advance of each Competition and, in respect of the Handicap qualifying events, will be allocated a Playing Handicap based on 95% of their exact Course Handicap on the day of the Competition.
